NATIONAL MINIMUM WAGE (AMENDMENT) ACT, 2011

An Act to amend the National Minimum Wage Act Cap. N61 Laws of the Federation of Nigeria, 2004 to provide for a revised national minimum wage and; for related matters.

ENACTED by the National Assembly of the Federal Republic of Nigeria:

1. The National Minimum Wage Act Cap. N61 Laws of the Federation of Nigeria, 2004 (in this Act referred to as “the Principal Act”) as amended, is further amended as set out in this Act. Amendment of Cap. N61 LFN, 2004
2. Section 1 of the Principal Act is amended in subsection (1) by substituting for the existing subsection (1) a new subsection “(1)”:

“(1) As from the commencement of this Act, it shall be the duty of every employer (except as provided for under the principal Act as amended) to pay a wage not less than the national minimum wage of ₦18,000.00 per month to every worker under his establishment”.
3. Section 3 of the Principal Act is amended in subsection (1) by substituting for the amount:

(a) ₦100.00 in line 5, the amount ₦20,000.00; and
(b) ₦10.00 in line 6, the amount ₦1,000.

Amendment of section 3
4. Section 5 of the Principal Act is amended by substituting for the amount:

(a) ₦100.00 in line 6, the amount ₦20,000.00; and
(b) ₦100.00 in line 6 the amount ₦1,000.

Amendment of section 5
5. This Act may be cited as the National Minimum Wage (Amendment) Act, 2011. Citation
